



# United Counties of Prescott and Russell

Among the First Municipalities in Ontario to Make the Digital Shift

**In spring 2018, five departments in the United Counties of Prescott and Russell adopted Notarius' electronic and digital signature solution.**



## Background

For several years now, the United Counties of Prescott and Russell have wanted to make the shift to digital technologies. At their IT department's initiative, the goal of this digital transformation was to improve and simplify their different departments' administrative processes. Unfortunately, after looking into the options, none of the solutions available seemed user-friendly enough to meet their needs.

## Pilot Project

In December 2017, the Association of Municipalities of Ontario (AMO) chose Notarius as their official provider of electronic and digital signatures. During a presentation of Notarius' solutions, the association announced that it was launching a digital transformation pilot project and that all of Ontario's municipalities were invited to participate. **Sign documents in batches** thanks to ConsignO Desktop.







## The Results


