

Projected Estimates of 2018 Net Upload Benefit

For each single and upper tier municipality, the table below provides a projection of the estimated net benefit of the announced social benefit program uploads in 2018, when the uploads are mature.

These projections are provided for illustrative purposes only. They are intended to capture both the decreased municipal costs associated with the uploads and the resulting decline in OMPF social programs grants. By 2018, the resulting net annual benefit to municipalities compared to their March 2007 OMPF is projected to total approximately \$1.5 billion.

Actual 2018 results for individual municipalities will vary depending on a number of factors, including court security costs, changes in social assistance caseload and other cost determinants.
