

Dear Minister Surma and Minister Flack,

I write to you in the spirit of collaboration to achieve our shared goals of enabling housing and economic growth while protecting the province from economic disruption.

Some have speculated that municipalities have slowed infrastructure investments in the face of tariffs and trade disruptions. However, AMO recently surveyed nine large municipalities and found that infrastructure spending actually increased this year:

Despite rising construction costs, many municipalities are actively increasing construction in 2025 to meet provincial housing targets, manage climate change, and maintain critical

infrastructure. This is positive news, but municipalities are still grappling with uncertainty and price escalation.

To help keep these projects on track and accelerate others, AMO recommends that your ministries:

- Increase contingency allowances for the Housing-Enabling Water Systems Fund and Municipal Housing Infrastructure Program to cover unexpected budget increases from tariffs and trade disruption. This will keep ongoing, provincially funded projects moving forward.
- Disperse unallocated Building Faster Fund dollars through the same existing Ministry
  of Infrastructure programs. With many over-subscribed, shovel-ready projects already in
  the queue, these funds can be put to work now. Investing in infrastructure today is smart,
  as it ensures it will be ready when the market rebounds and developers are prepared to
  build
- Increase funding to municipalities for infrastructure by delivering on your
  government's platform commitment. Allocating additional funding through existing
  programs is efficient, as municipalities have already invested in robust applications.
  Consider increasing the cap on the provincial share to enable more high-impact projects
  to proceed.

Accelerating our long list of shovel-ready municipal infrastructure projects would stimulate Ontario's economy, create jobs, and build the long-term infrastructure needed for a strong, resilient, and competitive provincial economy.

AMO appreciates your government's significant investments in municipal infrastructure in recent years. Now is the right time to respond to the urgency of the moment and increase these investments to protect our economy and support our housing and growth goals.
