2019/2020 JOINT ANNUAL MEMORANDUM OF UNDERSTANDING STATEMENT

We are pleased to present the joint statement for the Memorandum of Understanding (MOU) between the Association of Municipalities of Ontario (AMO) and the Province of Ontario.

The MOU sets out the principles and procedures of how the province consults with AMO on provincial legislation or regulations that have a significant impact on municipalities. Discussions at the table are considered confidential and AMO's advice is offered as input to the government's decision-making process.

Since 2018, we have worked together to convene the MOU table on a monthly basis, the past year has posed unprecedented challenges, which has resulted in even further engagement between the Province and the municipal sector. Since November 2019, we had a record 16 formal MOU meetings, covering 70 agenda items. These productive discussions have resulted in decisive action between both levels of government. In addition to formal MOU meetings, the Province has continually engaged AMO and its members on the government's response to COVID-19.

This year, the relationship between the province and municipal governments has grown stronger, and the partnership and spirit of collaboration that underpins the relationship has been instrumental in working together to manage the challenges facing Ontario's communities, as a result of COVID-19. This has allowed the Province to act quickly to meet the needs of municipalities, and keep them functioning, despite the challenges posed by COVID-19. These discussions have led to quick responses on several issues, including:

- initiatives introduced to support municipalities better during the emergency such as allowing virtual Municipal Council meetings and enabling redeployment of municipal staff to address priorities and needs;
- funding supports for municipalities including the Safe Restart Agreement funding and Social Services Relief Fund;
- staged approach to Reopening Ontario;
- delivery of the COVID-19 Fall Preparedness Plan to prepare for the second wave.

Working together, the provincial and municipal governments have kept communities running by providing critical services and relief to residents and businesses during the pandemic.

We have also jointly established the Provincial-Municipal COVID-19 Technical Working Group - a staff-level forum with tripartite participation from the Ontario Provincial government, AMO, and the City of Toronto. The Working Group has been meeting regularly since April 2020 and has

ensured a proactive approach to addressing emerging COVID-19 issues and developing solutions. This unique collaborative engagement is a testament to the strength of the provincial municipal relationship and has resulted in municipal governments providing ongoing input into COVID-related initiatives with potential impacts on the municipal sector.
